"A family may be thinking about protection, retirement timing and the financial impact of a changing household at the same time," Li said. "The purpose of a structured planning conversation is to help clients understand their

options and make decisions in an organized, practical way."

Li is a licensed insurance consultant with an accounting background. The company states that she holds CFP credentials and has received MDRT/TOT recognition, reflecting her professional experience in insurance and long-term planning discussions. Wise Planning Corp said its role is to help clients review available options and understand how different insurance and planning decisions may relate to their individual circumstances.

The firm provides support across life insurance, critical illness insurance, health insurance, travel insurance, general insurance and commercial insurance. Through Wise Planning Financial Solutions, the company helps clients evaluate how protection planning can fit with retirement preparation, household responsibilities, tax-related considerations and broader financial objectives.
